Sir

With reference to your letter No. n1 dated 4.7.79 on the subject cited above, I am directed to convey the permission of Director of Education, Delhi for extension in recognition to classes from I to VIII (without aid) for a period of 2 years i.e. 1.5.79, to 30.4.81 subject to the fulfilment of the following conditions:-

1. The Management shall ensure that it has adequate funds to meet its financial responsibilities for regular payment of salaries to its employees.
2. The management shall ensure that the accommodation and sanitary facilities as well as all requisite accommodation are provided to the institution keeping in view, any other facts, age and number of pupils attending it.
3. The management should employ teachers with prescribed qualifications only.
4. The school shall not run for the profit to any individual, group or Association of individuals or any other person.
5. Admission to the school shall be opened to all without any discrimination of religion, caste and place of birth.
6. The Managing committee shall observe the provisions of D.S.E.A. Rules, 1973.
7. The building and other construction in which school is carried, its surroundings, furniture and equipment are adequate and suitable for an educational institution, keeping in view the number of the pupils and subject taught in the school.
8. The building and other structure or the grounds of the school shall not be used during the day or night for commercial, residential purpose, political, non-educational activities.
9. The facilities prescribed under Rules 61 shall be made available to the institution.

(without aid) w.e.f. 1983-84 academic session.

sir,

With reference to your application on the subject cited above, approval for the upgradation of the existing Middle School to Secondary level is granted w.e.f. 1983-84 session subject to the fulfillment of following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules framed thereunder as well as the instructions issued from time to time by the Directorate of Education.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the Department.
4. That the school shall equip the Science Labs as per the norms of the Department and suitable facilities for practical work shall be provided to the students. Size of the two Science Labs may be doubled. Science material worth Rs. 10,000 (Ten thousand only) may be purchased immediately under Intimation to the Directorate of Education, Old Secretariat, Delhi.
5. That a proper library shall be established and trained librarian be appointed immediately. Facilities for reading rooms shall also be made available for teachers as well as students. Books worth Rs. 10,000 (Rupees Ten thousand only) may be purchased of approved courses of the Department immediately. Books as per the ratio of 10 books per student shall be provided.
6. That adequate sports material shall be purchased and made available to the students immediately. Proper play grounds for Hockey, Football and for other major games may be provided.
7. That the service contract as per the provision of Delhi School Education Act, 1973 may be executed immediately with the staff of the school and copies of the contract may be sent to the DDE(Act) for information and record.
8. That the school shall strictly abide by the provisions of sec. 10 (i) of the Delhi School Education Act & Rules, 1973.
9. That the existing temporary structure be replaced by pucca one and additional rooms of the size of 24'x20' to accommodate Secondary Classes be provided immediately.
10. That the enrolment in section shall not exceed the number of students calculated 12 sq.ft. per student for the available floor area of the classrooms and the school shall provide adequate and sufficient accommodation as per the norms of the department in each class. Number of sections should not exceed the number of existing classrooms of the proper size in the school.

11. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes be removed from the premises of the school, if any.
  12. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
  13. That the management of the school will obtain fresh health certificate from the competent authority of the area within a month.
  14. That the school shall strictly follow the provisions of rules 6, 7, 8 and 9 of the D.S.E.Rules, 1973..
  15. That all the facilities prescribed under rules 50 & 51 of the Delhi School Education Rules, 1973 shall be made available to the students.
  16. That the arrangement for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequate.
  17. That the Management of the school shall create a reserve fund of Rs.20,000 (Rs.Twenty thousand only) in a Joint Account in the name of Director of Education and the Manager of the School immediately.
  18. That the management of the school will not charge any development fee from the students as well as any extra fee for works experience and any special fee for teaching of English in various stages.
  19. That the violation of the instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of school.
  20. That a report about the fulfilment of the above conditions giving the extent to which each conditions is fulfilled, shall be sent to the Education Officer every six month.
  21. That the school will get itself affiliated to the C.B.S.E. under intimation to Director of Education, DDE(East) and the E.O. concerned.

6. That the school shall strictly abide by the provisions of Sec. 10 (j) of the Delhi School Education Act & Rules, 1973.
7. That the enrolment of section shall not exceed the number of students calculated at 812 sq. ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in one class. Number of sections should not exceed the number of existing classrooms of proper size in the school.
8. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at the place at the above address only. Nursery class be removed from the premises of the school, if any.
