While issuing allotment letter of land so recommended to the society/trust referred to above, it may be ensured that apart from other conditions as already prescribed by your office, the following conditions shall also be inserted in the allotment letter.

The society/trust must ensure that the school to be set up on the land allotted by DDA, is got recognised from the appropriate authority after fulfilling the conditions of recognition prescribed under sub-section (1) of Section-4 of DSER 1973 and the rules made thereunder. The construction of the building be carried out after approval of site plan from the competent authority.

Both the actions are required to be got completed within a period of three years from the date of allotment of land failing which the allotment of land to the society/trust shall be treated as cancelled of having found no interest to establish the recognised school for which it has been requested or to transfer the existing school

- Besides, that the society/trust shall ensure that the existing recognized school, if any, run by them is shifted at the new premises for which the allotment has been given above. The recognized school functioning at the previous premises, therefore, shall automatically stand, ceased to function at the old premises and in no case any class or section of that school shall be allowed to continue to function under the shadow of recognized school.

- a) The society shall not collect fee, contributions or other charges from any student of the recognized school under its control and supervision.
- b) In accordance with the provision of sub-rule (1) of rule 145 of the rules, the head of recognized school has been empowered to regulate admission in school or any class thereof either on the basis of admission test or on the basis of result in a particular class or school. Thus, the society/managing Committee or any other authority has been debarred from taking capitation fee or donation linked with admission.
- c) The school shall follow the instructions of the Directorate of Education for minimum/maximum enrolment of students in the school in the new building constructed on land allotted by the Govt. and atleast 75% of the students shall be admitted from the locality in which the school is situated.

In any case, it is established that the society/managing Committee, or any authority connecting with the school has collected capitation fee or donation as a condition of admission, the same shall be construed as valid ground for cancellation of allotment of land/determination of lease.

4. This sponsorship is valid for five years only and the allotment of land shall be made subject to, EC being valid and only in the area recommended. In case land is not available in the relevant area, LAC will be apprised and the society will be advised to approach LAC for fresh sponsorship in areas where land is available.
