- 4 Any deviations w.r.t. construction shall be verified by the concerned building sanctioning agency.
- 5 The certificate may not be treated in any case for the regularization of the unauthorized construction, if any.
- 6 The owner/ occupier shall apply for renewal of this Fire Safety Certificate to the Director in Form 'J' [sub rule (1) of rule 37] along with a copy of this certificate, six months prior to its expiry.
- 7 Basement shall be used strictly as per building bye laws.
- 8 The owner/occupier shall submit a declaration every year in the form 'K' provided in the first schedule of Delhi Fire Service Rules 2010, form is available on <a href="https://www.dfs.delhigovt.nic.in">www.dfs.delhigovt.nic.in</a>.
