Europe Educational Excursion Programme (7 Days)- May 2025

Dear Parent

Excursions play a vital role in a student's educational journey, providing learning experiences that go beyond the classroom. They allow students to connect theoretical knowledge with real-world applications, fostering a deeper understanding of concepts. Keeping this into perspective, the school is organising an educational excursion to Europe. The trip includes a guided tour of Paris (panoramic city tour of Paris, Alexander Bridge, Arc De Triomphe), Paris Disneyland, Eiffel Tower, Louvre Museum, Glass Pyramid, Seine River Cruise visit to Designer Outlet Mall, visit to Local University (subjected to approval), Zurich (Switzerland), Mt Titlis – Rotair – Ice Flyer, Lucerne Lake, Chapel Bridge, shopping on the busiest street of Lucerne near lake Lucerne, visit to Lindt Chocolate Factory and Rhine Falls boat ride to falls. (Itinerary is subject to change depending on flight and route availability)

Kindly note:

- Cost of the Programme: ₹ 2,50,000 +5% (TCS)= 2,62,500/-only (inclusive of tax collected at source).
- 5% is the TCS amount for which parents need to share their PAN card copy and they can claim the amount in their annual tax return.
- ₹ 50,000/- is the confirmation amount (non-refundable) to be submitted along with consent form.
- Last date to submit the consent form along with the confirmation amount is 22.11.2024 (Friday).
- Payment schedule for the trip:
 - > 1st payment (on or before 20.11.2024) confirmation deposit for the trip-₹ 50,000/- (non-refundable)
 - ≥ 2nd installment (on or before 10.12.2024) ₹ 1,12,500/-
 - > 3rd installment (on or before 10.01.2025) ₹ 50,000/-
 - → 4th installment (on or before 10.03. 2025) ₹ 50,000/-
- Cheque to be deposited in favour of 'AMATRA TRAVEL AND LEISURE PVT LTD'.
- The cost includes:
 - ➤ All sight-seeing, air tickets, stay in hotel on double/triple shared accommodation.
 - > Travel medical insurance
 - Visa fees
 - > Terms and conditions as per itinerary
 - ➤ All meals as per itinerary
- Parents who provide their GST Number will be eligible for a refund of the GST amount as well.
- Kindly also share a photocopy of passport of both student and parent.

The detailed itinerary will be given at the time of issuance of the ticket. In case of any change in the airline tax, the same shall be borne by the students. Interested students must submit a copy of their passport along with the consent form to start the processing. (Rates subjected to change in case of any increase in ROE/change in airfare/any addition in inclusions stated). Final itinerary will be given at the time of booking/issuance of air tickets).

- The booking will be treated as fully non-refundable. The cancellation can be requested only up to 90 days before the travel date. All cancellation notifications should be in writing.
- The travel agency will be doing medical travel insurance of all the students and teachers. (It is assumed that the guests booking the tour are medically fit to travel and also that he/she is aware about the tour programme and the different activities that shall be undertaken during the tour).
- The travel agency or its representatives shall have no responsibility of any kind towards any mishappening or any kind of accident or illness.
- Parents/guardian of children are giving their consent at their own free will and Amatra Travel and Leisure Pvt Ltd takes no responsibility in case there is a medical illness during or after the tour because of any reason.
- Any additional cost of such nature will have to be taken care by the student. On days when certain attractions, sights, monuments, museums, etc. are closed, the tour manager reserves the right to amend the itinerary/cancel the visit. There are no refunds for any services i.e. meals, sightseeing etc. not utilised during the trip.
- Any damage caused to the hotel rooms/coach during the stay, shall be borne by the concerned student. Over
 and above the cancellation policy as mentioned-above. If there is any extra or additional cancellation policy
 of airline, cruise, hotels or pre-booked plan etc. the passengers will be responsible for the same and have to
 be paid by the client.
