TERMS & CONDITIONS LAUNDRY SERVICES FOR BOARDING HOUSE TAFS

- 1. Bidder must understand the volume of work/business before submission of his bids.
- 2. The rates to be quoted should be inclusive of delivery and other incidental charges etc. Taxes/Levies, if any, should be specifically indicated separately in the quotations.
- 3. The Tenderer should abide by the rules and regulations of The Air Force School, Subroto Park, New Delhi.
- 4. Contractor is solely responsible for handling the Laundry Services and cannot delegate or involve third parties.
- 5. All the expenses with regard to the execution of the Agreement on Stamp Paper of Rs.100/- shall be borne by the Contractor which shall be executed in Delhi.
- 6. The provision of appropriate manpower, material supplies required for performing the tasks/processes of the Laundry Services shall be borne by the Contractor and other necessary appliances required for completing the Job shall also be arranged by the Contractor.
- 7. The Contractor should ensure disinfection of the clothes before washing.
- 8. The Vendor shall employ Laundry Staff who are above the age of 18 years. The Contractor shall be fully responsible for any complaints regarding misbehavior or misconduct by their employees.
- 9. If the clothes/uniform get damaged or lost at any stage in the laundering process, the Contractor is liable for replacement of the damaged or lost clothes/uniform with new one of same quality and quantity. If the contractor fails to replace the damaged or lost clothes then penalty shall be charged at present value of clothes Plus Rs.200/-.
- 10. The successful firm shall have to undertake the job of washing of clothes only after getting written orders from the school.
- 11. The Contract may be terminated or revoked at the discretion of the Principal, TAFS, Subroto Park, New Delhi without assigning any reason by giving 30 days written Notice.
- 12. The school reserves the right to accept / reject any or all quotations without assigning any reason.
- 13. The Complete job of collection of students' school uniform & other civil dresses from the Boarding House & deliver the same will be that of Contractor. The contractor has to collect the clothes weekly twice from the Boarding House on every Monday & Thursday and report to the Warden.

- 14. The timing of collection and returning of clothes should be in the evening hours i.e. between 1500 hrs and 1700 hrs.
- 15. The Contractor shall have to return the washed clothes within three days from receipt of the clothes from the Boarders failing which Rs.200/- fine for first instance and Rs.500/- on subsequent instances shall be levied as penalty.
- 16. In case the Contractor fails to render services to the satisfaction of the students / school authority, the school shall be at liberty to get the work done by any other party or to enter into a fresh Contract for the remaining period at Contractor's risk and expenses.
- 17. The contractor has to maintain a register in specified format for collecting and returning the clothes. He has to obtain the signature of boarders while collecting the clothes for washing and returning the washed clothes.
- 18. The contractor has to obtain the counter signature of the Warden in the register every time after returning the washed clothes.
- 19. The payment will be made on the basis of attendance of the boarders. For the attendance of 15 days or more in a month full month payment will be made. In case of attendance are less than 15 days in a month, payment will be made on prorata basis.
- 20. If the Contractor breaches any of the Terms and Conditions outlined herein, the school authority shall have the right to terminate the Agreement immediately, without prejudice to any other rights. Additionally, the school authority shall be entitled to forfeit any due payments, if applicable.
