- 9. That the school shall disband, with the services of unqualified and over-aged staff, if any, immediately.
- 10. That the Management of the School will obtain land from DDA in the name of the society through Dte. of Education, Delhi and shall construct a school building thereon for the proposed school as per the specifications of the department. The normalize of the class-room will be 24' x 20'. No other activities other than education shall be run.
- 11. That the service contract between the management and the employees shall be executed immediately.
- 12. That all the facilities prescribed under rule 50 & 51 of the DSEA, 1973, shall be made available to the students. Provisions of rules 5, 7, & 9, be strictly observed.
- 13. That the arrangement of good drinking water shall be made available to all the students/teachers and sanitary facilities shall be also be provided to the students immediately. Health certificates may be obtained from the local body within a month.
- 14. That the management of the school shall create a Reserve Fund of Rs. 5,000/- only in a Joint Account in the name of the Director of Education and the Manager of the school in any scheduled bank within a month.
- 15. Proof to the effect that the staff has been appointed as per the Recruitment Rules be provided to the E.O. for his verification.
- 16. Copies of the appointment letters issued to the staff be provided to the E.O. for his verification.
- 17. That the violation of any instruction/order/conditions rules & regulations of the department shall lead to the withdrawal of recognition of the school and clause IX shall not be opened without the prior approval of the Director of Education, Delhi.
- 18. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the Education Officer every six months.

- 10. The Management Committee shall regulate the functioning of school strictly in accordance with the provision of DSER, 1973.
- 11. The Managing Committee of the school shall not increase Fees in future academic session without prior approval of Director of Education which is a mandatory requirement under Sub section(3) of section 17 of Delhi School Education Act & Rules
- 12. That all the facilities prescribed under rule 50 and 51 of the DSEA and Rules, 1973 shall be made available to the students
- 13. Proof to the effect that qualified staff including the Principal appointed as per Act & Rules be provided for the verification of the E.O. concerned.
- 14. That the staff has been paid all arrears and being paid salary as per fourth pay commission if any. Proof of the same be given to E.O. concerned.
- 15. That the arrangement for good drinking water shall be made available to all the students as well as the teachers and sanitary facilities shall also be provided to the students adequately.
- 16. That the school shall comply with the norms of the DSER, 1973 for affiliation for examination purpose.
- 17. Medical facilities/leave, LTC, bonus, Teaching allowances, Provident fund etc. be paid since recognition of school.
- 18. Provident Fund register be maintained and cashbook be completed and shown to E.O. of the Zone concerned for verification from time to time.
- 19. That the Management of the School shall create a reserve fund in the form of Fixed Deposit in the joint account in the name of Dy. Director of Education (South-West) and the Manager of the school equivalent to 3 months salary of the staff.
- 20. That the violation of the instructions/conditions/rules and regulation of the department shall lead to the withdrawal of recognition of the school.
- 21. In no case the school funds will be diverted/transferred to any other fund/account of the society. The school funds shall not be utilised by the society for any other purpose other than that of the school.
