4. That the school complies with the orders/guidelines of DoE and judicial pronouncement related to safety of students and will take all necessary step in this regard.
5. That the school shall appoint the staff as per existing RRs.
6. The school shall pay salary and other benefits to its staff as per ongoing CPC and as per Sec. 10(1) of DSEAR, 1973 through ECS/cheque and Rule 125 of DSEAR, 1973.
7. That the school shall submit the latest School Health Certificate from Competent Authority to District Authorities within 30 days of after issuance of this letter.
8. That the school shall appoint one more Special Educator within 30 days of after issuance of this letter.
9. That the school shall submit the documentary proof regarding Installation of Rain Water Harvesting System in the school premises within 30 days of after issuance of this letters.
10. Building Completion Certificate (BCC) or Occupancy certificate be submitted .
