# Dr Manmohan Singh Passes Away at 92

Dr Manmohan Singh, former Prime Minister of India, passed away in New Delhi at the age of 92. He died at the All India Institute of Medical Sciences after being admitted in critical condition. Singh had been unwell for several months and lost consciousness at home before his hospitalization and despite medical efforts, he was declared dead at 9:51 PM.



As Finance Minister under Prime Minister PV Narasimha Rao, Singh played a very important role in liberalizing India's economy in 1991. His policies aimed to reduce government control, promote foreign investment, and enhance economic growth. These reforms marked a shift in India's economic landscape. Dr Singh served as Prime Minister from 2004 to 2014, leading the Congress-led United Progressive Alliance (UPA) government. His administration focused on inclusive growth, poverty alleviation, and social welfare. He was known for his calm demeanour and economic expertise.

Sindhoora Raja, at just 15 years old, has proven that age is no barrier to brilliance. Hailing from Ullal, Mangaluru, and









# Ocean Anoxic Event 1a (OAE 1a) December 27, 2024

Scientists have recently studied ancient rocks and

fossils from Mount Ashibetsu in Japan uncovered and details about Ocean Anoxic Event 1a



(OAE 1a), which occurred approximately 119.5 million years ago. This event caused a critical lack of oxygen in the oceans and led to extensive extinctions, particularly among plankton.

OAE 1a was likely triggered by massive undersea volcanic eruptions. These eruptions released vast amounts of carbon dioxide (CO<sub>2</sub>), which warmed the planet and disrupted ocean oxygen levels. The combination of high CO<sub>2</sub> and low oxygen created a hostile environment for marine life.


# Indore Airport to Become India's First




