FEE POLICY, ADMISSION CANCELLATION AND REFUND POLICY

Admission at DPS, Dwarka Expressway starts with a provisional admission and if you wish to accept the offer, the following fee is required to be deposited on the day of the offer to secure seat for your ward.

- Admission Fee
- Caution Money
- Quarterly Fee will be payable at the time the session starts

Provisional admissions will be processed and converted to a confirmed admission only after submission and verification of the required documents, and the deposit of all applicable fees before the start of the academic session.

1. Fee Payable

A. Admission Charges *(payable only at the time of admission)*

- Registration Fee
- Admission Fee
- Caution Money

B. Regular Charges *(payable quarterly, which includes the following)*

- Composite Fee
- Lab Charges (applicable for Grade IX–X)
- Lab Charges (applicable for Grade XI–XII, as per subjects)
- Transport* (optional, applicable for 11 months)
- Meal Charges* (optional, applicable for 11 months)

Transportation Fee: Grant of admission to school does not guarantee a seat in the school bus. Parents seeking bus facility for their wards, therefore, should confirm the suitability and availability of bus routes and convenience of bus stops from the Transport Manager before making any payments towards reservation of seats or towards confirmation of admission.

C. Other Applicable Charges for Additional Facilities (optional):

Payable towards additional services such as:

- Sports Club before and after school
- Therapies and additional learning support charges
- Outbound Trips
- Before and after school activity
- Weekend Clubs
- External examination charges
- Counselling Support
- College Advisory Support
- Specialized Student Projects
- Off-campus sporting/cultural events
- Tours/trips/learning expeditions/annual camps/school function

Note: These amenities are optional and may be obtained as per the terms, conditions, and charges stated by the responsible School/third-party vendor.

The Fees does not include the cost of books, stationery, uniforms, and/or excursions and/or tour facilitators' charges for our field trips or out-bound trips and/ or any such additional activities/ amenities as these costs are variable depending on the destination, time of travel, and/or facilities involved. Information including but not limited to all costs will be shared closer to the date of the scheduled excursions. These payments are also typically made directly to the external trip facilities.

Please note that the school has attempted to make the fee policy as comprehensive as possible. However, there may be other fees/ charges that become payable from time to time which shall be notified by the school to the parent.

2. Mode of Payment

- All fees are payable and accepted in Indian Rupees only.
- Fee payments may be made through the following options only (Please note that the school does not accept cash payment for fees):
- Cheque drawn in favor of Delhi Public School, payable at Gurugram, can be dropped at the school's accounts office OR through Payment Gateway
- While making any payment, please include the student's name, grade, and details of parent/guardian and registration number of the child.
- All bank charges on inward remittance of fee, if any, shall be debited to the student's account.
- If any cheque is returned as dishonored, a processing fee of INR 300/- in addition to the applicable bank charges and late payment charges will be debited from the student's account.

3. Fee Payment Due Date

- The Quarterly Fee as mentioned above is due at the start of each respective quarter of the academic year, namely on or before the 10th of April, July, October & January respectively. A reminder with the amount due will be communicated to all parents, however, even if no reminder is issued, the liability of payment shall be that of the parent/guardian.
- Delay in payment of fees would result in a late fee penalty of Rs. 100/- (Rs. hundred) per day being levied until the outstanding dues are paid in full. In the event of an unjustified/unauthorized delay on a recurring basis, a temporary suspension may be instated till the clearance of the fee. In case, however, of continued delay/failure to pay the fee, it may (after notifying the parents) lead to striking off the name of the student from the rolls of the school.
- If parents have any query or objection related to school fee, then it does not mean that parents will not pay the quarterly fee on or before time. It is compulsory for parents to clear their dues before or on the due date, even while the issue is being resolved. Otherwise, point no. 3(b) will be implemented.

4. Admission, Withdrawal and Refund Policy

- A parent/ guardian may request withdrawal of their child/ children through written communication on school portal or mail at info@dpsgurgaon.in filling. On withdrawal of a child from school, the following will be admissible refunds and claim of parent:

In Case of New Students/admissions:

Registration Fee & Admission Fee - Non- refundable whether the student has commenced classes or not.

5. Force majeure:

- In case of occurrence of any force majeure condition which causes the school to close down for such period of time as may be necessary and/or mandated and/or which causes physical classes to be suspended, in part and/or in whole, the Parent/Guardian shall be required to pay the composite fee and/or any other charges (as may be stipulated by the school) for the entire period of such closure and/or suspension of classes. The parent/guardian shall also not seek any refund of paid fees and/or charges for such a period of closure/suspension.
- Force majeure condition(s) shall mean and include but not be limited to any act of nature such as fire, earthquake, cyclone, floods, etc., epidemic and/or pandemic, disease, air pollution, weather conditions, strike, riot, agitation, Govt. notification, court order, change in applicable law, etc., and/or any act which is beyond the reasonable control of the school.



6. Policy Review and Revision

Any change in fees policy and fee structure will be subject to approval of school management Committee and in case of any increase or change in fees for the applicable academic session, it will be duly notified to the parents via written communication.
