**Water Pipeline Network Disinfection**

**Scope of the work:** chlorination & disinfection of the water tank and the water supply network to remove bacterial contamination inside the pipeline network.

Note: It is very important that people using the water under the system to be chlorinated are well informed in advance to avoid getting into contact with chemically treated water.


