Preamble

The Faculty Development Program on "Integrating Universal Design to Foster Inclusive and Accessible Environments" is designed for architectural educators committed to advancing inclusive design practices within the built environment. The Harmonized Guidelines and Space Standards for Barrier-Free Built Environment for Persons with Disabilities and Elderly Persons (2016), issued by the Ministry of Housing and Urban Affairs, further reinforce these requirements.

By aligning with these government mandates, faculty will gain a deeper understanding of how to integrate these guidelines into design curricula, ensuring that future architects are well-prepared to create spaces that are not only functional but also inclusive, equitable, and welcoming for everyone.



Current Roles:

Senior Advisor for Inclusive Health Policy at Disability Rights India Foundation: I take forward
research and advocacy measures towards health equity for persons with disabilities including
Rehabilitation and assistive technology at the national and state level. Based on my



continuous advocacy, the Department of Health, Govt of Tamilnadu has recently notified 21 disability committees under the National Health Mission program. I have been continuously advocating for streamlining accessibility health care standards based on the requirements of all 21 disabilities. I am also involved in working with the Department for Empowerment of Persons with Disabilities, Govt of India in campaigning for health insurance of all persons with disabilities including Multiple Sclerosis as well as the notification of updated disability assessment guidelines by DEPWD. I continue to campaign for Universal Health Coverage of all persons with disabilities under the #UHC4INDIA campaign apart from coordinating the efforts of the disability movement for inclusion of disability questions in National Family Health Survey 6 (NFHS6). Following the exclusion of disability, my writ petition seeking inclusion in NFHS is under trial at the Madras high court since July 2023. My role involves leading research work, writing/reviewing documents, developing communications / campaigns, engaging with stakeholders nationally and internationally and documenting progress.

- Lead Facilitator, Equality Pillar, Begin to Live Interdependently with Support Systems (BLISS), Vidya Sagar, Chennai: With a motto of deinstitutionalization of persons with disabilities and enabling their safe and independent living within the community, I am engaged in facilitating community resource mapping for individuals with Disabilities and their families, develop individual support plan and support circles for them in the community, fostering community support systems to enable independent living and safe environment for them. I am currently working on a community support model at Kotturpuram. I facilitate development & execution of legal trust deeds for individuals with high support needs, based on their specific needs and preferences. I am also involved in capacity building of support professionals such as caregivers etc.
- Accessible Elections Advisor: As a member of Accessible Election Committees at the State and
 Distirct level (and with extensive expertise from working as Accessibility Consultant at ECI,
 New Delhi 2017 2022), I support the respective departments by evolving and collaborating
 on successful strategies on accessible elections as well as enabling consultations with multi
 stakeholders to enhance Inclusive & Accessible Elections. My recent contribution to accessible



elections was to draft and facilitate the "Advisory to political parties in respect of persons with disabilities", as notified by the ECI on 20th December 2023. Currently I am focussing on elections from the lens of climate change and Disability in addition to strategizing accessibility of all polling stations in the upcoming State Legislative Assembly elections 2026 as well as promoting Advisory in respect of Persons with Disabilities with all political parties. I speak in National and International webinars on accessible elections apart from attending the disability inclusive elections dialogue at Kathmandu, Nepal conducted by International Foundation for Electoral Systems (IFES) in september 2024 where I supported IFES in assessing the accessible electoral process of 5 South Asian countries Bangladesh, Nepal, Sri Lanka, India and Pakistan. The Accessibility Section of ECI is keen on strategizing accessible elections based on climate change as per my inputs as a member of National Advisory Committee for Accessible Elections.

- Managing Committee Member, MSSI, Chennai: I continue to collaborate with the Department for Welfare of Differently Abled, Govt of Tamilnadu as well as Department for Empowerment of Persons with Disabilities, Govt of India on enhancing the medical and social rehabilitation of persons with multiple sclerosis. In addition, I execute the role of peer counsellor for fellow persons with MS, campaigner/ collaborator with multi stakeholders to create awareness on MS (including working on entitlements such as health insurance, disability guidelines, quality Disease Modifying Therapies etc for persons with MS).
- Roles at International platforms: As a Council Member of the World Health Summit, I advise on inclusion of disability & health discussions at the Summit, person centered care including Rehabilitation, mental health and assistive technology within the health spectrum, engagement of more persons with disabilities and accessible operations at the Summit. As an Advisory Group Member of Civil Society Alliance for Human Rights on Pandemic Treaty, I review (zero) draft input on strategies to include disability rights within the discussions on the pandemic treaty and ensure community approach with regard to the same. As a member of Global Patient Think Tank, I am instrumental in evolving the UHC COMPASS in line with the CRPD approach. I speak at international platforms such as UN, WHO, WHS, UHC2030 etc



towards ensuring health equity for persons with disabilities and including the same at all levels of discussions on health care and Rehabilitation including SRHR & Mental Health.

• Other significant contributions at local level in the recent time: I contributed as an expert for

Multiple Sclerosis to the study on direct cost to disability in the State of Tamil Nadu by Centre

for Inclusive Policy.

Department for Welfare of Differently Abled Persons by Vidya Sagar, which is a display and

experiential centre for assistive aids & adaptations towards facilitating independent living of

Persons with Disabilities. Also worked on similar settings including adapted games at Purple

NCPEDP- Azim Premji Foundation) on Accessible Health care services for persons with

policy advocacy that is interconnected at the 3 levels. I am persistent in my efforts towards enhancing

accessibility within my hometown Chennai or advocate for policy changes with health ministries at the

State and national levels or work out new strategies with accessibility division of ECI or discuss way

forwards for health equity of Persons with Disabilities at International platforms such as World Health

Summit, UNITE Summit, WHO consultations on SRHR, self care, NCDs, Mental health etc. On a day to

day basis, I fight my chronic fatigue every moment in which my parents are a great support, in

addition to the numerous infections - UTI, RTI, stomach infections, viral fevers, allergies etc some of

them due to usage of public toilets and being in crowd for advocacy activities. Though I get severely

sick almost every week, as soon as I feel better you can see me sitting in Marina and Besant Nagar

beaches discussing beach access with my team and GCC officials or campaigning for accessible

buses. I travel abroad despite my infections carrying all the antibiotics and regular medicines, to voice



the health rights of persons with disabilities and importance of community health engagement within the health systems at global and community level. 24 years of multiple sclerosis with many relapses and bouncing back has made me physically weak but I regain hope when I see small successes in my work that takes disability inclusion to the next level.

• **Key Focus:** Ar. Shivani Shah led an insightful discussion to challenge traditional perceptions and myths around disability. She emphasized the need for a shift in mindset, encouraging participants to think beyond stereotypes and focus on the varied needs of people with disabilities. By fostering empathy, the session set the tone for the upcoming discussions on inclusive design.

Session 2: "Nothing About Us Without Us" - Stories, Barriers, and Enablers

• **Key Focus:** The second session focused on the principle of "Nothing About Us Without Us" and how the lived experiences of people with disabilities must inform design processes. Ar. Shivani shared real-life stories and highlighted the barriers faced by people with disabilities, along with potential enablers that can create a more inclusive environment.

Session 1: Accessibility Laws and Rights




