Sub: CBSE Notice reg. Optional Examination for Improvement/Compartment Examination for Class XII, 2020

Please find enclosed herewith CBSE Notice No. CBSE/coord/2020 dt. 14.07.2020 has informed reg. the Compartment Examination for the students who could not obtain qualifying marks in one subject or have not appeared for the examination in any one subject in class XII Examination 2020.

Vide aforesaid Notice, CBSE has intimated that the Board will conduct Compartment Examination for those students who could not obtain qualifying marks in one subject or have not appeared for the examination in any one subject. CBSE has also informed that the Board will also conduct optional examination for the candidates whose results have been declared based on the assessment scheme, in the subjects whose examinations were scheduled to be conducted from 01st July, 2020 to 15th July, 2020. Candidates will be allowed to appear in these optional examinations to improve their performance, if they wish so. Marks obtained by a candidate in these optional examinations will be treated as final.

Further, students who applied for improvement of Performance, 2nd chance Compartment and for Additional subject in 2020 and their examinations could not be conducted, shall also be eligible to appear in the examination conducted for above two categories. CBSE has further informed that the dates of conduct of examination will be informed soon in consultation with Government of India.

In this regard, the Heads of all the Govt., Govt. Aided and Un-Aided Recognized Schools are directed to disseminate this information among those students of class XII who could not obtain qualifying marks in one subject or have not appeared for the examination in any one subject or those students who wish to appear to improve their performance, through Whatsapp group/bulk SMS or other suitable means available.

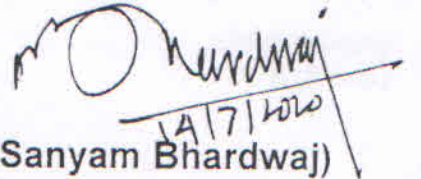
NOTICE

In addition, CBSE will also conduct optional examination for the candidates whose results have been declared based on the assessment scheme, in the subjects whose examinations were scheduled to be conducted from 01st July to 15th July 2020. Candidates will be allowed to appear in these optional examinations to improve their performance, if they wish so. Marks obtained by a candidate in these optional examinations will be treated as final.

Also, students who applied for Improvement of Performance, 2nd chance Compartment and for Additional subject in 2020 and their examinations could not be conducted, shall also be eligible to appear in the examination conducted for above two categories.

The dates of the conduct of examination will be informed soon in consultation with Government of India.
