Sub: Public Draw of Lots for selection of representatives for constitution of School Level Fee Regulation Committee for the Academic Session of 2025-26.

Please note that in compliance with The Delhi School Education (Transparency in Fixation and Regulation of Fees) Act, 2025 ("**Act**") and the Delhi School Education (Transparency in Fixation and Regulation of Fees) Rules, 2025 ("**Rules**") and pursuant to the directions issued by the Directorate of Education, Government of National Capital Territory of Delhi ("**DoE**"), vide Order dated 24.12.2025 bearing reference No. DE.15(431)/PSB/2025/9744-9752, Notice is hereby given for the constitution of the School Level Fee Regulation Committee ("**SLFRC**") for the Academic Session of 2025-26.

The SLFRC shall be responsible for reviewing and recommending the proposals for fee fixation/ revision, ensuring compliance with the Act, Rules and the directions issued by the DoE.

To ensure impartiality and transparency in the selection process, a public draw of lots shall be conducted to select the parent and teacher representatives for the committee.

Schedule of Draw

- Date: Tuesday, 20.01.2026
- Time: 02:30 PM
- Venue: Bloom Public School

Composition to be Selected

- Parent Representatives: Five (5) members.
- Teacher Representatives: Three (3) members.
- Waiting List: Ten (10) additional members will be drawn to fill any future vacancies.

The draw shall be supervised by the nominated Observer/ Nominee of the DoE.

Eligibility and Participation Guidelines

The selection process shall adhere strictly to the eligibility criteria outlined in the Act, Rules and the referenced DoE Order:

- Eligibility: All parents/guardians of students currently enrolled in the School for the Academic Session 2025-26.
- Exclusions: Parents/guardians of students admitted under Economically Weaker Section (EWS), Disadvantaged Group (DG), or Children with Special Needs (CWSN) categories (exempted from fee payment) are ineligible in accordance with 4.1 of the DoE Order.

- One Family Representation Rule: Only one parent/ guardian per family (irrespective of the number of siblings enrolled) shall be eligible for selection. In the event of multiple family members being drawn, only the first-drawn name shall be validated.
- The entire process shall be video-recorded in compliance with the Act and Rules.
- Participation in the draw does not guarantee selection; it is purely by lot.

All concerned parents, guardians, and teachers are cordially invited to attend and witness the proceedings in person. Your presence will contribute to upholding the principles of transparency and accountability enshrined in the Act and Rules.
