



## OFFICE ORDER

In pursuance of the provisions of the Delhi School Education (Transparency in Fixation and Regulation of Fees) Act, 2025 and the Rules framed thereunder, and in compliance with the directions issued by the Directorate of Education vide Order dated 24.12.2025, the School Level Fee Regulation Committee (SLFRC) of the school was duly constituted pursuant to a transparent draw of lots conducted on 07.01.2026

Subsequently, as per order no. F. 
