


Greetings of the Day Readers!



Encouraging Education and Empowerment: This day also promotes the education and empowerment of girls, encouraging them to be strong, independent, and confident individuals.




WOMEN'S RIGHTS IN INDIA


Pre-Independence (1915-1947)


